### **Autumn Term 2023**

### GOV 01: Governors' briefing - Autumn

The Governors' briefing is a termly meeting which includes updates on the latest developments in governance, information about best practice and policy information from the DfE. The meetings also give governors the opportunity to network and share experiences with other governors.

The meetings will be especially useful to Chairs of Governors and Chairs of Committees but are relevant to all governors who want to stay well-informed about educational developments which impact on governance.

## GOV 02: Holding the HT and staff to account - your role in performance management

Governors are responsible for ensuring high standards in schools, which is dependent on having high quality teaching and learning taking place. Governors therefore need to be confident that the school has effective systems in place to manage staff performance and the performance of the headteacher.

The national teachers' standards are used to hold teachers to account and there are national standards for headteachers which outline the ethics and professional conduct expected of them, as well as providing ten headteacher standards which build on the teachers' standards.

This briefing will update governors on their role in staff appraisal and headteacher performance management by exploring the different standards as well as looking in depth at governors' roles and responsibilities.
